# IDAHO TAX CREDIT

Donations to Lake City Academy qualify for a 50% tax credit. This is a reduction in the amount of tax you owe. If you itemize your taxes, a donation to LCA allows income tax deductions on both your state and federal returns, plus a 50% Idaho income tax credit.

- *Idaho individuals may take up to 50% of a gift of \$1,000 (a tax credit of \$500)*
- *Idaho married couples may take up to 50% of a gift of \$2,000 (a tax credit of \$1,000)*
- *Idaho corporations may take up to 50% of a gift of \$10,000 (a tax credit of \$5,000)*

Your tax benefit is dependent on your personal income level and filing status. Please consult with your tax professional for additional information.
